Charter Change Timeline

The Statutes allow for Charter amendments to be initiated either by the legislative body (the City Council) or by petition of five percent of the registered voters. The hearing and adoption process is similar but not identical, depending on how the amendment is initiated. For our purposes, I will focus on amendments proposed by the Council.

- 1) The first requirement is that an official copy of the proposed Charter amendments must be filed with the City Clerk at least 10 days prior to the first public hearing on the amendment. That means that a draft of the amendment must be on a Council agenda in sufficient time to allow for formal adoption of the item and the timely filing of that item with the Clerk.
- 2) Charter amendments require two public hearings. The first public hearing MUST be held more than 30 days prior to voting day. The second must be held in advance of the election, but the timing is otherwise not specified.
- 3) If the Council changes the proposed amendment based on comments heard at the first public hearing, the revisions must be posted publicly and filed with the Clerk at least 20 days prior to the election day.
- 4) Otherwise, notices of the Charter change must be warned and publicized in the same manner as the Annual or Special Town Meeting.

WEEKLY UPDATES FROM DEPARTMENT HEADS ...

Public Works Department

Montpelier Water System – Musty Smell and Taste Issue:

About two weeks have now passed since the Water Treatment Facility implemented the recommended remedies to address the unpalatable water system issues. DPW staff calculates that it takes about 15 days for the water storage reservoirs and distribution system to completely turn over and be replaced with new water flows. Staff has observed that no new complaints have been received since the improvements were made with one person commenting that the issue has been addressed. This person told us, "Sometime over the past week, the odor and taste issue completely went away". The City often hears about what is wrong but less is said when something is ok, and we assume that no news often can mean good news. As the winter months approach and the organic load affecting taste and odors naturally decreases in the water source, the Treatment Plant will begin reducing the amount of activated carbon in the finished water process. The amount of carbon used to flush out the system was at plant capacity and this reduction will be phased in over the next several weeks. Public Works expects the water quality will now remain stable but will continue to monitor all aspects of the system.
