Public Health and Safety

Coronavirus (COVID-19)
City of Montpelier Response Update
Weekly Report Date October 16th

With the uptick in cases in the Montpelier region, it's more important than ever to reemphasize the importance of following COVID-19 safety guidelines, washing your hands, and masking up! It is up to all of us to protect one-another from this virus.

The State has also recommended that Vermonters get their flu shots to ensure fly cases stay down to make sure that our hospital capacity stays available for those who may need COVID-19 treatment throughout the rest of the fall and into the winter.

As a reminder to residents: The Governor has made it mandatory to wear a mask in public starting August 1st.

Weekly State Updates:

- o Governor Scott Extends State Of Emergency To November 15
 - In addition to helping the state manage the public health risks, the State of Emergency keeps supports in place to mitigate economic hardship resulting from the pandemic. These protections include expanded housing and meal delivery systems, expanded eligibility for unemployment insurance, resources for businesses and federal emergency funding.
- o Training for Vermonters Impacted by Covid-19 through the Community College of Vermont
 - The Community College of Vermont announced <u>free</u> college courses and training for the next 2 months to Vermonters whose work and household situations have changed due to COVID19.

o Health Updates:

- Cases within Schools
 - Union Elementary in Montpelier has had 2 identified cases. This is the State's first inschool transmission.
- Regional Update:
 - The outbreak associated with hockey and broomball teams in Montpelier is up to 18 cases. The cases are within players and their close contacts.
 - Testing will be available in Barre this Saturday (Oct. 17th). People can register for the pop-up clinic at <u>www.healthvermont.gov/covid19-testing</u>
 - The State is only recommending those associated with the outbreak- such as those associated with the Civic Center or these specific sports teams.
 - Current case counts can be found on the <u>VT Health Department dashboard</u>.

o Travel Update:

- The State discussed safe holiday travel, noting that there are not many 'green' counties
 outside of Vermont to travel to and from without quarantining. They encouraged all
 Vermonters to not let their guard down, and to work hard to travel safely and follow the
 guidelines. See the updated cross state travel map for more information.
- o Long Term Care Guidance Updates:
 - Indoor visitation will be allowed in counties where the positivity rate is low, as federal rules
 outline. For counties with higher case counts, only outdoor visitation and compassionate
 visitation will be allowed. And if there is a case in the facility, visitation will be halted.COVID19
- o Simpler PPP Forgiveness for \$50K Loans or Less
 - The <u>U.S. Small Business Administration (SBA) has released a simpler loan forgiveness application</u> for Paycheck Protection Program (PPP) loans of \$50,000 or less.

City Updates:

o City Hall will be open for the public during regular Council Meetings. The public will be able to interact with the Zoom Council Meetings in the Council Chambers. Masks or a face shield and social distancing will be <u>required</u> inside City Hall. Masks will be on-hand with City Staff if members of the public do not have any available to them.

o Halloween Recommendations:

- o The Montpelier Mayor, City Council, and City Manager recommend that residents refrain from Halloween Trick or Treating this year. Recent COVID 19 outbreaks in the City are a reminder that the pandemic continues and that Montpelier is as vulnerable as any other area. Neither the City nor Montpelier Alive will be sponsoring or holding any organized Halloween activities such as downtown trick or treating or the Recreation center party.
- The City does not have internal public health expertise and so has been relying on the Vermont Department of Health and the Center for Disease Control (CDC) for public health guidelines since the beginning of the pandemic. The State has not taken any official position with regard to trick or treating, but the CDC has released guides for low-moderate- and high-risk activities. People who choose to celebrate Halloween should understand the risks and are advised to follow guidelines from the CDC.


DPW Street & Water/Sewer Divisions:

Department of Public Works Street Division

The Water/Sewer Division has spent all of this week continuing on N College Street installing the water main. This project will continue through all of next week.

The streets division has spent this week prepping for pavement on Clarendon Ave, patching potholes, street sweeping, leaf pickup, and assisting on the N College Project. Next week crews will likely begin removing pavement on Cummings Streets as we will be converting this street to gravel for the duration of the winter.

City Council approved the new Alternate Side Parking on October 14th, 2020. Be on the lookout for the following flyers around the city as well as on Vehicles.



Our Street Division will also be producing new street signs for the Alternate Side Parking. These signs will begin being placed throughout the city within a week. Please see an example of the sign below:

The Council asked about the number of tickets issued and tows required during winter parking bans. Here is the data from the last three years:

2018

591 winter ban tickets issued

17 "tag and tow" events called by DPW

238 vehicles were identified to be towed (unknown exact number towed as some move and some the tow company runs out of time to get)

511 winter ban tickets issued

22 "tag and tow" events called by DPW

295 vehicles were identified to be towed (unknown exact number towed as some move and some the tow company runs out of time get)

2020

197 winter ban tickets issued

5 "tag and tow" events called by DPW

67 vehicles were identified to be towed (unknown exact number towed as some move and some the tow company runs out of time get)

Bike Path:

The tree board and parks division will be planting trees from their nursery either late this week or early next.

Work on the new bike path rail crossings will resume next week with path closures expected. They'll finish the crossing at the end of Old Country Club Rd and then move to the crossing near Gin Lane. No work planned until Monday.

Completion of the bike path section from Main Street to the new bridge, along with landscaping the accompanying parcels is still expected to be completed before snow falls this year.

Street paving:

The street paving contract for FY21 was approved at the last City Council meeting. Pike Industries is the contractor and they will be paving the following areas: the eastbound lane along Memorial Drive between National Life Drive and Taylor Street, Clarendon Avenue, Jordon Street, and Redstone Avenue. The work will begin next week and will continue through the following.

Taylor Street:

All of the curbing along Taylor Street has been installed. Sidewalks will be poured over the next two weeks.

Due to the public health crisis, not only is our city seeing a shortage on toilet paper, but many communities are as well. *The Department of Public Works would like to remind everyone about what should NOT be flushed.* Flushing the items listed below could cause sewer blockages, which could cause plugged and overflowing toilets, poorly draining sinks and showers, raw sewage backing up through floor drains and/or manholes overflowing onto the ground or into nearby surface waters, health hazards and nuisance odors, and this could result in increases in the City's maintenance costs and costly repair bills for involved residents.

The following items should NOT be flushed!

- Paper towels
- Baby wipes
- Moist towelettes
- Cosmetics and cosmetic wipes
- · Cloth or paper napkins
- Shop towels

- Condoms
- Tampons and pads
- Diapers
- Cat litter
- Cigarette butts
- Dental floss
- Latex gloves
- Hypodermic needles
- Facial tissues
- Fats, oils or grease
- Clothing or rags
- Medications (pills or liquid)
- Bandages
- Cotton balls
- Food scrapes
- Swiffer pads
- Plastic of any kind

COUNCIL MEETING DATES

To avoid conflicts with holidays, the Council will hold regular meetings on the following dates:

- November 4 and 18
- December 2 and 9
- January 13 and 21 (Thursday). The 27th is not yet confirmed.

Additional dates for **budget workshops** may be added including one between December 9 and 31 and another one on January 6th.

TEMPORARY PARKLET APPROVALS

As per ordinance, parklets must be removed by October 25.

Although the terms of the temporary ordinance were originally intended for 2020 only, we may wish to revisit this in early 2021 to determine whether conditions warrant an extension.

12 MAIN STREET (former TKS property)

As we know, the City needs to make a decision about whether to purchase this property for the \$134,000 of federal funding that was spent to to acquire it as part of the One Taylor Street/Bike Path project. We have made a proposal to VTrans for this purpose and will bring the issue to the Council when we have received a response. It was originally scheduled for this next meeting.

Police Department modified lobby opening

The Montpelier Police Department's front lobby will remain locked, but available once again for prescription drug drop offs. Residents are asked to ring the front door buzzer to speak with dispatch and to wear a mask when entering the building. Anyone showing any signs of sickness is asked to stay away from the building and only one person will be allowed in the lobby at a time. The Department will also be hosting a DEA drug take back day on October 24, 2020 between 10am-2pm.

POLICE REVIEW COMMITTEE

The following has been advertised with an application deadline of October 22nd for council consideration on the 28th. We have received 11 applications

The City of Montpelier seeks interested residents to serve on a Police Review Committee. The number of members and length of terms has yet to be determined. The City Council has charged the committee with the following work:

- 1) Review the historic functions of Montpelier police department;
- Review modern policing trends and practices, such as those embodied in the President's Task Force on 21st Century Policing and other reference materials;
- 3) Meet with community stakeholders for feedback on the role and function of the Montpelier Police Department. (list of stakeholders will be provided but can be expanded)
- 4) Review existing historic law enforcement data for trends, significant issues, and other observations or conclusions that are relevant to current and future planning and funding of the Montpelier Police Department. (list of data will be provided but can be expanded)
- 5) Review and analyze the functions of the Montpelier Police Department, its existing policies, and help create the Department's current strategic plan
- 6) Compile the information into a report to be delivered to the City Council by June 30, 2021. The report will include recommendations for this committee's future charge and function.

SCHOOL RESOURCE OFFICER

Council Member Jay Erickson was appointed to represent the City Council on the School Board's review committee. I will be speaking with Board Chair Jim Murphy today about the appropriate Police representation.
